CHECK IN TIME: will be at 8:30 a.m. Test dog will run at 9:00 a.m. Please check in at the starting point for your stake.

GROUND: There is an area for airing your dogs. Please keep the grounds clean, pick up after your dogs and park on designated roads.

DIRECTIONS: Take I-25 to the Berthoud Exit 250 (HWY 56). Go West off the ramp through the town of Berthoud. Continue west until the road turns north and becomes North County Road 23 (about 9.4 miles). At the first road Weld County Road 8e go west or left. Continue west on WCR 8e toward Carter Lake Reservoir and start climbing up past a switchback (about 3.6 miles). Go straight past a turn to the reservoir and continue past the lake on your right and a boat launching area as the road turns south. Continue to the Dorband's property entrance at the end of South CR 31 (about 3 miles). After going through the entrance turn right and meet at the small house.

ENTRIES: CLOSE WED., September 14, 2011 AT 6:00 PM MDT . Complete your entry. Return with payment to Test Sect'y, ASAP. Entries cannot be accepted after closing. If sending by special delivery, waive requirement for signature as entries will not be picked up. Running order will be conducted by secretary following closing. Include a stamped, self-addressed postcard to confirm receipt of entry and running order. Email and telephone inquiries re: running order cannot be guaranteed to be responded to.

POT LUCK & AWARDS: Please bring a dish to share. Drinks & paper goods will be provided. Awards will be presented following completion of tests.
